

### **AUTHOR'S AGREEMENT AND RIGHT**

In consideration of publishing 'the Contribution' to the journal "Scholars Journal of Research in Social Science", written solely by the respective Author(s) / Co-Author(s) who are submitting and/or registering his Contribution / Work with the journal "Scholars Journal of Research in Social Science" and who retain(s) his individual copyright on the texts published as the Author's Contribution / Work. IT IS AGREED:

1. (a) In consideration of and subject to the terms and conditions set forth in this Agreement, the Author(s) / Co-Author(s) hereby grants the Editor/Publisher the sole and exclusive right and license to sign an agreement with any organization deemed suitable by the Editor/Publisher to publish the Contribution in all forms and media throughout the world for the duration of the legal term of copyright. The Author(s) / Co-Author(s) submitting to the journal and/or registering co-authored Contributions ensures that all issues between co-authors regarding copyright, title, order of appearance, personal data, and any other issues, including legal/financial ones, are resolved; s/he has the full authority to represent the interests of all co-authors and bears full responsibility. The Editor/Publisher is not liable for any disputes that may arise between the Contribution's author(s) and co-author(s).
2. The Author thus claims his or her right to always be recognized as the author of the contribution in line with Estonian law.
3. The Author(s) agrees to acquire and provide to the Editor/Publisher upon delivery any written rights necessary to make use of any textual or illustrative material contained in any portion of the Contribution/Work by the Author that does not bear the Author's copyright. Wherever possible, such permissions shall include a non-exclusive right to use the said material in print and electronic editions of the Work in all languages worldwide and in all revised editions of the Work, and where they do not, the Author shall notify the Editor and Publisher when providing the written permissions. The Author shall pay all applicable permission and reproduction costs.
4. The Author(s) acknowledges that the final typescript of the Contribution may be edited by the Editor and that such changes will be considered to represent the Contribution's final version. At the Editor's discretion, the Author may be asked to review the Contribution's proofs. The Author must bear the expense of changes to the Contribution's proofs (text and artwork), save for corrections of mistakes made by the printer, publisher, or any independent actor.
5. (a) The Author(s) acknowledges that the Editor and Publisher have the exclusive right to negotiate and execute the transfer of the right to publish/reproduce the contribution (or any portion thereof) in any form or media and in any language, alone or in conjunction with other authors or collaborators. (b) The Author acknowledges that under the terms of this Agreement, works published by the Editor/Publisher are included in the non-exclusive licensing schemes operated by such Reproduction Rights Organizations and that any fees due for copying the Contribution under said schemes shall be paid in accordance with the license terms then in effect.
6. (a) The Author warrants to the Editor and Publisher, as well as their licensees, printers, and distributors, that the contribution is original to him/her; has not been previously published in any form, and is not currently being considered for publication in any form by any third party; and contains nothing that violates any existing copyright or license, or duty of confidentiality, or duty to respect privacy. The Author warrants to the Editor and Publisher that the contribution does not contain anything libelous or unlawful; that all statements purporting to be facts are true; and that any recipe, formula, instruction, or equivalent contained therein will not cause injury or damage to the user if followed precisely; and that s/he has full authority to enter into this agreement. The Author warrants to the Editor and Publisher that s/he will indemnify and hold them harmless against any loss, injury, or damage (including any legal costs and disbursements paid by the Editor or Publisher to compromise or settle any claim, as well as any costs and disbursements that the Editor or Publisher may be required to pay by any legal notice).  
(b) All guarantees and indemnities included in this Agreement shall survive the expiration of the Author's copyright and shall be binding on the Author's heirs and assigns.

7. The Author must not do any conduct that demonstrates dishonesty or moral turpitude and which may significantly harm the Editor's and/or Publisher's reputations or endanger the Contribution's success. If the Author is charged with an indictable offense involving dishonesty or moral turpitude, the Editor and Publisher reserve the right to take mitigating action against the Contribution, including but not limited to suspension of publication and removal from the journal's website, as well as from any databases and indexing systems.

8. The Author acknowledges that the Editor and Publisher are bound by the Data Protection Act and that the term "Personal Data" has the meaning ascribed to it in said Act, as well as in international and Estonian laws governing the processing and distribution of personal data. The publisher may use the Author's Personal Data to administer and publish the Work. This provision shall remain in effect after the termination of this Agreement.

9. The Author acknowledges that, in carrying out their obligations under this Agreement, the Editor and Publisher may disclose to the Author information that is proprietary and/or confidential to the Editor and/or Publisher, including but not limited to the terms of this Agreement, market research data, and marketing and editorial plans for the Contribution. The Author agrees to maintain the confidentiality of all information obtained from the Editor and Publisher that is not readily available from a public source and to refrain from disclosing such information in a manner that would be detrimental to the Editor and/or Publisher or the Contribution's success. This provision shall remain in effect after the termination of this Agreement. Any Author (Co-Author/s) who submits his/her Contribution to the Journal and/or registers it with the Journal acknowledges that he/she has read and understood the terms of this agreement and fully affirms that s/he complies with the conditions of this agreement.
